The Association for Childhood Education International – Hong Kong & Macau Chapter (ACEI-HKM) has run smoothly in the period of 2014 and 2015. Periodical Executive Meetings have been organized to oversee the activities of the Chapter.

Dr. Ramsey Koo, our former and first President, has continued been appointed the International Ambassador of the Chapter under the new term of office. Mr. Michael Kam, our Past President, has continued to be EXCO member of the Hong Kong Teachers' Centre from 2014 as a representative of the Chapter.

Two EXCO meetings have been called in September and December 2014. A Hong Kong AGM has called in December 2014, and a Macau AGM held in February 2015.

### **Newsletters and Activities**

A new issue of Newsletter has been published in October 2014.

The latest issue covers useful Information of the Chapter. An article, *Environment Planning and Children's Learning* by Ms. Joyce HO, in echo to the November Environment and Sustainability Educational Forum in Taiwan was also published. For the November Taiwan Forum, a special edition of Newsletter, under the editorial of William MA and Titus Li, has been published. Papers for the Forum and Abstracts are included in the Newsletter. Like other publications of ACEI-HKM, the Newsletter can also be downloaded under the *Newsletter Manu* from the Chapter's web site.

Another new edition of the Newsletter in September 2015 has been planned.

The Chapter has joined with Chinese Society for Environmental Education and co-hosted an "International Exchange Conference on Environmental Education and the 5<sup>th</sup> Cross-Straits & Four Regions Sustainable Development Education Forum 2014". The Forum, which carries a main theme on "Towards our Common Future: Environmental Education and Interdisciplinary Links", has been held from 14-16 November 2014 in Peng Tung, Taiwan. ACEI-HKM Chapter, with the chairs of William Ma and Titus Li, vice-presidents of the Chapter, with school delegates from Macau attended the two-day Forum. The group has made seven paper presentations in the Forum. One of the papers by Li, Choi & Wong has won a presentation prize in the Forum.

The meetings with a Hong Kong Education Publisher on collaboration of ECE books has been fruitful. A contract was signed between the Publisher and ACEI-HKM in December 2014 on a commissioned ECE book to be published in early 2016. An editorial team with three members from the Chapter has since been formed to organize the project. As in late July the progress has been following the time plan with all manuscripts received and sent to reviewer for blind review. The editorial team has also started the drafting of introduction and conclusion chapter for the commissioned book.

The book is planned to be the first one of a series with theme on early childhood education.

The Chapter remains financially healthy with a balanced budget over the year.
